

COVID19/Coronavirus Policy

March 13, 2020

If you are sick or experiencing symptoms (for example - fever, cough, shortness of breath, etc.), please be considerate of others by <u>not</u> entering the New Castle County Government Center. Please seek appropriate medical attention and conduct your business by one of the methods listed below. If you display symptoms, you will be asked to leave the premises.

The health, safety, and well-being of our residents and customers is of the highest priority for the New Castle County Department of Land Use. Internally we have educated our staff on proper hygiene, social distancing, self-quarantine in instances of suspected or confirmed contamination, and other guidance provided by the Centers for Disease Control. Further the Department has reduced or eliminated in-person meetings, opting instead for interactions via video and telephone conferencing as available, and reduced non-essential business-related travel for all employees.

While the risk to the general public from the coronavirus currently remains relatively low in Delaware, **we need** our residents and customers to take advantage of convenient ways to conduct business with us by one of the following methods:

Online Services for Building Permits & Related Transactions

Many building permit-related transactions can be conducted online without visiting the Government Center. Please visit the <u>Online Services</u> webpage to learn more about these services. You can start most building permit applications online through the following services:

- <u>DynamicPortal</u> For Plumbing and HVAC Applications

All other application types, along with those referenced above, can be submitted via email or mailed to the Department through the addresses previously provided.

Inspection Scheduling

Zoning Certifications

Zoning Certifications may be obtained through submission of an <u>Application for Zoning</u> <u>Certification form</u>. Applicants may use this certification for several purposes, such as to secure financing, obtain a license from another agency, or to determine whether a property is legally suitable for their desired use.

The form is available for download <u>here</u>. This form must be submitted via postal mail along with the applicable fee.

Subdivision/Land Development Plan Review Services

All proposed land development plans and rezoning applications, and any required fees, are to be submitted via postal mail to the Department of Land Use, 87 Reads Way, New Castle, DE 19720 until further notice.

Land Development Project Search

Project Search provides you with information and status on development plans, Board of Adjustment applications, RPATAC Applications and zoning certifications that are being or have been reviewed by the Department. You may access the Project Search system <u>here</u>.

Code Enforcement/Property Maintenance Violations

- You may report a concern or check the status of a submitted complaint here.
- Code enforcement violations may be paid or appealed here.
